- Spring Season
 -
 - 2 Children out with concussions
 - Remind coaches that concussion training is mandatory
 - A few problems with coach disagreements on the field
 - Team blow outs
 - Cursing on the field
 - Argument between coaches about players
 - Child should never be asked to leave the field
 - Need to remember this should not happen in front of players
 - Ensure all Coaches are aware of process to deal with disagreements
 - Spring picnic – 6/15
- Registration
 - Numbers are very low
 - Robbinsville to try and encourage Division 2 players

- Scholarships

- Fields & Grounds
 - Princeton Irrigation has not yet addressed sprinklers.
 - Jack had Sean's Landscaping to come out and provided estimate. \$13,600 for trench drain; \$1,400 fill low spots with topsoil and sod; Irrigation for small fields \$3,700
 - Paul has contact with Landscaper and will try to coordinate additional estimate
